С	Railings and banisters are sound and inspected periodically.
0	Steps and walks are kept free from ice and snow.
0	Yard/play space are free from holes, stones, glass, etc.
С	Tools and dangerous articles are out of reach of children.
0	Dangerous products & chemicals are kept in original containers in locked storage areas.
0	Wires and low fences are brightly painted or clearly marked.
2	Wells, cisterns, and pits are kept securely covered.
2	Disposable materials are not burned outside.
2	An area is marked off in the garage for bicycles, wagons, etc.
2	Lawn mower is equipped with proper safeguards.

2	Good ventilation exists, especially when sanding or painting.
